

Pleasant Valley Road and Piedmont Avenue development

t the February PANIL meeting, John Protopappas (developer) and Kirk Peterson (architect) presented plans for the vacant lot at the corner of Piedmont Avenue and Pleasant Valley Road. The design is an Italianesque structure intended to appear as if it is a number of different buildings to lessen the visual impact. Protopappas has a long history of highly-regarded projects in Oakland. including the Tribune Tower and the Sears building renovations. Peterson is also well regarded for his projects, mostly in Berkeley, which, he is proud to say, most people think are renovations of historic buildings rather than new construction. His best-known Oakland Project is the YWCA renovation.

The lot at Pleasant Valley Road is governed by two different zoning regulations. As the applicable code is not clear, the plans are not final. The building will be either 35 or 40 feet high facing Piedmont Avenue and lower on the end toward Howe Street. Open space will be provided by a 20 foot wide central courtyard as well as a roof terrace above the residences on Pleasant Valley Road.

The project as currently planned consists of 26 market-rate housing units above two 1,500-sq-ft retail spaces. A total of 33 parking spaces are to be provided, based on a puzzle parking system (see: http://www.hyundaielevator.co.kr/enhtml/auto3.html). The entry will use the current curb cut on Piedmont Avenue.

Protopappas estimated that construction would take approximately twelve months and, if all goes well, would begin about September 2005.

Neighbors questioned whether planned parking was adequate. Some

suggested that parking be sold separately from the apartments so that residents would be encouraged to use bicycles, transit and Car-Share. Possible traffic congestion was also discussed as were the problems of construction noise and disruption.

What will occupy the retail spaces? When Protopappas indicated that it was too early to know, PANIL members expressed their hope that the new businesses would increase the diversity on the Avenue and not add to the number of food establishments with their traffic and parking demands. Local residents cautioned that prospective buyers should be warned about the noise at that corner from Kings-X, the Ken Betts car wash and normal traffic.

How do we fund an expansion?

t its February meeting, PANIL's Library Committee heard from two City of Oakland employees, Mark Morodomi of the city attorney's office and Jerry Garzon of the library department. Morodomi reviewed methods of funding for an expansion of the current library or a new library. He outlined the basics of the formation of an assessment district and discussed other approaches that might be available. Garzon answered the committee's questions about a possible new bond measure in 2006 that may be put before Oakland voters for a new main library and could include funds for selected branch libraries, perhaps including Piedmont Avenue. He also brought the committee up to date on current library projects in the city, including the newest 21,000-sq-ft branch on 81st Avenue.

While Piedmont Avenue's much-loved library is the second smallest branch (at 1,700-sq-ft) in Oakland and can get quite "cozy" during busy times, the committee's aim is not to "grow" a huge, impersonal library. Rather, the goal is to triple the space and keep the coziness. It is clear from funding projections that librarians will be fewer than ever in the immediate future, and large libraries could find themselves with sections roped off for lack of personnel to support the space.

The committee welcomes community comment. Meetings are held on the first Wednesday of every month at 7 pm at

Condo conversion laws to remain

fter a lively discussion at PANIL's meeting last August, the members present agreed to send representatives to the Coalition to Protect Rental Housing which was formed to resist the weakening of tenant protections under Oakland's 1981 Condominium Conversion laws. The coalition was effective; attempts to change the city's rules for conversion of rental units to condominiums have been dropped for now. A coalition representative informs us that there was an effort in the state legislature to preempt local controls. A bill was introduced but it failed to get out of committee. However, the vote in committee was close, so the issue will bear watching during the next legislative year.

80 seats approved in restaurants

The public comment period has ended for two additional food use applications at 4301 Piedmont, the new building at John Street. The proposals, which have been approved by the Planning Department, total 80 seats in two restaurant spaces: 34 for an Ethiopian restaurant, and 46 for an ice cream parlor and candy shop.

PANIL's letter (and letters from several neighbors) raised concerns regarding the over-saturation of restaurants and the high traffic and parking demands they generate. The new building not only eliminated 6 - 8 parking spaces and increased the number of restaurant seats on the property, but it provides no loading zone to ease traffic obstruction for deliveries to the restaurants.

The nearby school crosswalk makes traffic especially worrisome.

In response to PANIL's concerns, the new permit for the specialty food market/deli requires that seating cannot be added without public review.

Permit rescinded for advertising bus shelter at Linda Avenue

The permit was rescinded for a large bus shelter with advertising that was to have been installed at the front of the public plaza at Piedmont and Linda Avenues. The property owner of 4184 Piedmont had appealed the permit on behalf of his tenants, concerned that the shelter would block sight lines to the businesses. PANIL's letter to the City emphasized that the shelter would also unreasonably constrict sidewalk space and impinge on the enjoyment of the plaza.

According to AC Transit, only seven bus riders board at this stop during an average day. It appeared that AdShel's wish for a shelter at this site was more for advertising visibility for Piedmont- and Montclair-bound drivers than sheltering riders.

The appeal hinged on narrow technical grounds. Director of the Public Works Agency, Raul Godinez II, ruled that PANIL had, in fact, objected to the shelter as required during the public comment period in August, 2002

Thanks to neighbors and shoppers who signed petitions and sent e-mails to Director Godinez.


